Environmental factors, particularly dust from the adjacent road, remain a challenge and accelerate façade soiling. To preserve the refreshed look, NK Cleaning Services recommends adopting a structured maintenance program with quarterly façade cleaning.

Introduction

Scope of Work

- Tile Cleaning: Scrubbing of roof tiles to eliminate dirt, dust, and discoloration.
- Curved Area Restoration: Cleaning of heavily stained brown surfaces and repainting to restore neatness.
- · Canopy Cleaning: Washing of blue canopies at both front and back entrances to enhance visibility and appearance.

Findings and Observations

- Dust Accumulation from Road: The building façade is continually exposed to dust carried from the nearby road, accelerating soiling even shortly after cleaning.
- Improved Visual Appeal: Before-and-after inspections confirm a significant enhancement of the building's aesthetics following the cleaning exercise.
- Need for Regular Maintenance: Environmental exposure necessitates scheduled cleaning to sustain a professional
 appearance.

Recommendations

- Regular façade washing At least 3 to 4 times annually.
- Routine gutter and tile maintenance To prevent clogging, staining, and potential water damage.
- Periodic canopy washing To maintain a clean and welcoming entrance.
- Paint touch-ups Where necessary, to preserve the neat and professional outlook of the building.

Area of Improvement

We would further recommend that during the tile façade cleaning, signage repairs, steel metal rusty pipes painting, broken façade glass replacement, tile grouting at the top, painting works on the exterior walls, and the parking lot be done together to give a refreshed outdoor outlook of the entire facility.

Conclusion
